3. General Description of Security Measures (Art. 32(1) GDPR)

Replenit implements technical and organizational measures to ensure a level of security appropriate to the risk, including:

1. **Encryption:** All data is encrypted in transit (TLS 1.2+) and at rest (AES-256) across all sub-processors.
2. **Access Control:** Strict Role-Based Access Control (RBAC) enforced via Single Sign-On (SSO) and Multi-Factor Authentication (MFA) for all engineering staff.
3. **Pseudonymization:** Direct identifiers are separated from processing data where technically feasible.
4. **Resilience:** Automated backups and disaster recovery protocols hosted in redundant availability zones.
5. **Audit:** Regular vulnerability scanning and code reviews.
